- Revision H** – 09 Dec 2004: Released SB100664 for use in NJ. **As required by the New Jersey Division of Gaming Enforcement (DGE), replacement of the previously approved program SB100313 must be accomplished before March 02, 2005.**
- Revision I** – 27 Jan 2005: Released SB100661 and SB100664 for use in MS.
- Revision J** – 31 Mar 2005: Released SB100661 for use in NM. Released SB100664 for use in IN.
- Revision K** – 25 Aug 2005: NMT was added to the approved area of SB100664.

**CONDITION(S):**

On machines using the Triple Double Wild Cherry paytables SB100312 and SB100313, the graphical blank symbols were sometimes lit on the reels for non-winning combinations. This is only a lighting issue and does not affect any pays.
